EDGEWORTH DAVID MEDAL**

The Edgeworth David Medal is awarded each year for the most meritorious contributions to knowledge and society in Australia or its territories, conducted mainly in New South Wales and made by an individual who is in mid-career.

The Edgeworth David Medal was established by Council in 1943 in honour of pioneering geologist Sir T. W. Edgeworth David FRS, who compiled the first comprehensive record of the geology of Australia. In September 1942, Henry Ferdinand Halloran, who had joined the Society in 1892, celebrated his jubilee as a member by making a donation of which Council used part to establish the Edgeworth David Medal for young scientists. It was first awarded in 1948 and in 2023, Council determined to award it annually to mid-stage career researchers.

Nominations open on 1 July each year and close on 30 September. Awardees are announced by the end of that calendar year with formal presentations of their Awards in the following year. All nominations require a nominator and a seconder who need not be Members of the Society. Recipients may be resident in Australia or elsewhere. Nominees for the Edgeworth David Medal must be no less than 5 and no more than 15 years from the award of their PhD or equivalent on 1 January of the year of nomination. All Royal Society of New South Wales awards are assessed relative to opportunity.

Each nomination must comply with the conditions of award and will consist of a completed nomination form together with supporting documentation as specified on the form.
